<u>Background</u>: This request is to remove BI 124/L and BI 125/L from the BS Chemistry—Biology Dual Degree Program. This reduces the program credit hours by 8 credit hours, for a total of 99–100 credit hours. The inclusion of these courses was an oversight (these courses are intended as requirements in the Pre-Pharmacy track, not the dual degree track), that was not detected until it was too late to make this change.
