**MINIMUM QUALIFICATION:**

Bachelor's Degree with 5 years relevant and related work experience with extension-type course/workshop planning, implementation, and evaluation.

**QUALIFICATIONS REQUIRED:** Pursuant to Public Law 26-87 as amended by Public Law 29-113, all future employees of any position within the government of Guam will be required at minimum to possess one of the following:

1. A high school diploma; or
2. Successful completion of General Education Development (GED) Test; or
3. The equivalent of a general education high school program; or
4. Successful completion of a certification program, from a recognized accredited or certified vocational technical institution, in a specialized field for the job.

**KNOWLEDGE, ABILITIES, AND/OR SKILLS:**

Ability to conduct research, analysis, budgeting, framing, writing of program plans and grant applications. Strong written composition and media skills, social media experience, preparation of basic event announcements. Knowledge of basic Microsoft Office applications.

**CHARACTER OF DUTIES:**

Under the supervision of the Associate Director of Extension & Outreach, the Extension Associate II will perform research and suggest opportunities to increase College of Natural & Applied Sciences and University of Guam's, knowledge infusion into Guam's public and private high schools so that students are better prepared for college and/or have knowledge that they would not have otherwise. Utilize various media (print, social, on-line, etc.) for participant communication and recruitment for outreach activities. Research and suggest ways to establish a broad-spectrum intern/experiential learning program for College of Natural & Applied Sciences and University of Guam. Research and implement "College of Natural & Applied Sciences Life School" – short course education events for critical life-skill topics, specifically highlighting Extension outreach and engagement to targeted audiences in Guam. Provide guidance/implement evaluation for special/emerging project topics and events, such as College of Natural & Applied Sciences Guam *Gene-ius* program. Provide support to Associate Director for program evaluation as needed. Submit timesheets and time and effort reports. Perform other duties as assigned.

**EDUCATION:**

Applicants claiming degrees or credit hours are required to have an original or certified copy of the documents (e.g., Transcripts, high school diploma or GED certification) accompany the application.

**WORK ELIGIBILITY:**

Submission of completed job applications authorizes the University of Guam to seek and obtain information regarding the applicant's suitability for employment. All factors which are job related may be investigated (e.g. previous employment, educational credentials, and criminal records). All information obtained may be used to determine the applicant's eligibility for employment in accordance with equal employment opportunity guidelines. In addition, the applicant releases previous employers and job related sources from legal liability for the information provided.

Section 25103, Chapter 25, Title 10 of the Guam Code Annotated requires college or university employees to undergo a physical examination, to include a test for tuberculosis (skin or x-ray), prior to employment and at least annually thereafter. A report of such examination must be conducted by a licensed physician within a state or territory of the United States and must be submitted upon request.

## **EXTENSION ASSOCIATE II # 044-18**

Federal law requires presentation of eligibility to work in the United States within seventy-two (72) hours of reporting for employment. Specifically, 8 USC 1324A requires the employer to verify the identity and eligibility to work in the United States of all newly hired employees. The University of Guam is required to comply with this law on a non-discriminatory basis. If you are hired to fill a position within the University of Guam, you will be required to present valid documents to comply with the law.

### **POLICE AND COURT CLEARANCE:**

Pursuant to Public Law No. 28-24 and Executive Order No. 2005-34, applicants selected for a position are required to provide original police and court (Superior Court of Guam) clearances of no more than three (3) months old prior to commencement of employment. Off-island applicants must obtain clearances from their place of residence. Applicants are responsible for fees associated with obtaining the clearances.


