Resolution No. 19-42

**RELATIVE TO APPROVING THE PROPOSED ADJUSTMENT OF STUDENT FEES
EFFECTIVE FAÑOMNĀKAN (SPRING) 2020**

WHEREAS, the University of Guam (UOG) is the primary U.S. Land Grant institution accredited by the Western Association of Schools and Colleges (WASC) Senior College and University Commission (WSCUC) serving the post-secondary needs of the people of Guam and the Western Pacific region;

WHEREAS, the governance and well-being of UOG is vested in the Board of Regents (BOR);

WHEREAS, UOG from time to time re-evaluates fees charged to students to ensure that the fees are reasonable and are used for their intended purpose;

WHEREAS, there are several types of fees at UOG, such as, General Fees which are paid by all students; Course Fees, paid by students taking certain UOG courses; Service Fees, paid by students for certain services offered at UOG; and Residence Halls Fees, paid by residents of UOG Student Housing;

WHEREAS, UOG has proposed the adjustment to General Fees, specifically the Recreation/Wellness, Sports, and Fieldhouse Fee; the adjustment of Course Fees at the School of Engineering (SENG), the School of Education (SOE), and the College of Natural and Applied Sciences (CNAS); the adjustment of Residence Halls Fees; and the adjustment of certain Service Fees; all of which are detailed in Attachment A of this resolution;

WHEREAS, UOG has also reviewed some of its costs and fees over the last year and has determined that some fees should be adjusted and new fees implemented at this time as reflected in Attachment A of this resolution;

WHEREAS, the University has proposed the fees adjustment and made them publicly available with an economic impact statement per 5 GCA Article 3 Section 9301 (f);

WHEREAS, at their joint October 2019 meeting, the Student Affairs, Scholarship, Alumni Relations, and Honorary Degree (SASARHD) Committee and the Budget, Finance and Audit (BFA) Committee reviewed the proposed fees adjustment and held a joint public hearing on October 11, 2019 to receive input on the proposed fees; and

WHEREAS, the Committees and the UOG President recommend to the BOR the approval of the proposed fees adjustment in Attachment A.

NOW, THEREFORE BE IT RESOLVED, that the BOR hereby approves the proposed adjustment to student fees as detailed in Attachment A of this resolution, effective for Fañomnåkan 2020;

BE IT FURTHER RESOLVED, that the UOG President is delegated the authority to defer or adjust any individual fee up to the amount stated in Attachment A should the UOG President determine that the fee may have a negative impact on the operation of the University; and

BE IT FURTHER RESOLVED, that the UOG President is delegated the authority to "grandparent" course/program fees without a public hearing in instances where a new or existing course/program without a fee, requests a fee that is similar enough to currently approved fees and has already been approved by the BOR.
