**RELATIVE TO EXPRESSING CONDOLENCES TO THE FAMILY OF THE
LATE DR. ROSA R. CARTER**

WHEREAS, on the passing of Dr. Rosa R. Carter, the University of Guam community wishes to express its sincere condolences to her widower, her siblings, and her family members; and

WHEREAS, Dr. Rosa R. Carter was born on August 29, 1929, the child of the late Jose Duenas Roberto and the late Antonia Santos Garrido Roberto; and

WHEREAS, Dr. Rosa R. Carter married Dr. Lee D. Carter, a retired University professor; and

WHEREAS, Dr. Rosa R. Carter graduated from George Washington High School in 1950, received her Bachelor of Science degree from Northern State University (Aberdeen, South Dakota) in 1953, completed a comparative degree at Sydney University (Sydney, Australia) in 1958, and earned her Master of Arts degree in Guidance and Counseling from Northern Colorado University (Greeley, Colorado) in 1962; and

WHEREAS, Dr. Rosa R. Carter was one of the first Chamorro women to receive a doctoral degree when she earned her Doctorate of Philosophy in Education Supervision at Bowling Green State University (Bowling Green, Ohio) in 1976; and

WHEREAS, Dr. Rosa R. Carter was an educator who was employed as an elementary teacher for the Government of Guam; a high school teacher for the Guam Catholic Schools; and an Associate Professor at the University of Guam, teaching both graduate and undergraduate level courses; and

WHEREAS, Dr. Rosa R. Carter was a leader in the education community, having served an Assistant Principal at Wettengel Elementary School and as the 4th President of the University of Guam from 1977 to 1983; and

WHEREAS, Dr. Rosa R. Carter was a public servant and was involved in the Girls Scouts, American Red Cross, Guam Council of Women's Club, Soroptomist International of Guam, Association of University Women and Delta Kappa; and

WHEREAS, Dr. Rosa R. Carter was instrumental in the commissioning of the University of Guam Alma Mater.

NOW THEREFORE, BE IT RESOLVED, that the Board of Regents of the University of Guam, the administration, faculty, staff and students, convey to the family of the late Dr. Rosa R. Carter their sincerest gratitude for her dedication to the University

and the people of Guam, for her exemplary life of service, and for her devotion to the future growth and prosperity of our island; and

BE IT FURTHER RESOLVED, that copies of this resolution be sent to the widower and family of the late Dr. Rosa R. Carter, to the Governor of Guam, and to the Speaker and members of the thirtieth (30th) Guam Legislature.
