**RELATIVE TO EXPRESSING APPRECIATION TO HYO SANG JI FOR HIS SERVICE
AS A MEMBER OF THE BOARD OF REGENTS**

WHEREAS, upon the resignation of Hyo Sang Ji as a member of the Board of Regents (BOR), the University of Guam (UOG) community wishes to express its sincere gratitude for his dedication and service;

WHEREAS, Hyo Sang Ji earned a B.S. in Nutrition and food science from the University of California Berkeley in 1995; earned a Doctor of Medicine from St. Luke's College of Medicine in the Philippines in 2005; completed his Internal Medicine/Internship in 2008 and Anesthesiology/Residency in 2011 from the State University of New York at Buffalo;

WHEREAS, Hyo Sang Ji is an Anesthesiologist and Medical Director at the Guam Surgicenter;

WHEREAS, Hyo Sang Ji has received certifications and licensures to include the Guam Board of Medical Examiners, American Board of Anesthesia, American Society of Anesthesiologist, Basic Life Support Trainer, Advance Cardiac Life Support, and Pediatric Advanced Life Support;

WHEREAS, Hyo Sang Ji provided volunteer service to the St. Luke's College of Medicine Extern Program; the Guam Memorial Hospital Externship Program; and the United States Peace Corp as a Nutrition and Health Education Volunteer, serving two consecutive two-year contracts in Guimaras/Iloilo Province, Philippines;

WHEREAS, Hyo Sang Ji was confirmed as a member of the BOR on January 20, 2016 to serve a full six-year term, and served until his resignation effective May 31, 2019 to further his medical training;

WHEREAS, as a member of the BOR, Hyo Sang Ji served on the Budget, Finance and Audit Committee and the Investment Committee from January 2016 to May 2019;

WHEREAS, Hyo Sang Ji brought experience and knowledge as a successful professional and a responsible leader to the BOR, and provided valuable influence in working with both policy makers and the Administration in addressing issues impacting UOG;

WHEREAS, Hyo Sang Ji's commitment and leadership in support of UOG and higher education as a BOR member is recognized, commended and greatly appreciated;

WHEREAS, Hyo Sang Ji is highly regarded for his humbleness, cordiality, thoroughness, sound judgement and holistic consideration in decision-making; and

WHEREAS, the AP&T Committee has reviewed the recommendation and recommends approval of this resolution expressing appreciation to Hyo Sang Ji to the BOR.

NOW THEREFORE, BE IT RESOLVED, that the BOR of UOG, the administration, faculty, staff and students, convey to Hyo Sang Ji their sincerest gratitude for his dedication to UOG and the people of Guam, for his service as a member of the BOR, and for his devotion to the growth and prosperity of our island; and


