RELATIVE TO EXPRESSING APPRECIATION TO RANDALL V. WIEGAND FOR HIS DEDICATION AND SERVICE IN HIS ROLE AS THE VICE PRESIDENT OF ADMINISTRATION AND FINANCE, AND CHIEF BUSINESS OFFICER WITH THE UNIVERSITY OF GUAM AND GOVERNMENT OF GUAM FOR 28 YEARS

WHEREAS, upon the retirement of Mr. Randall V. Wiegand on July 31, 2025, the University of Guam (UOG) community wishes to express its sincere gratitude for his dedication and service;

WHEREAS, Randall V. Wiegand has dedicated over 28 years of exemplary service to the Government of Guam, including a decade of distinguished leadership as Vice President of Administration and Finance and Chief Business Officer, where he contributed greatly to the financial integrity, operational efficiency, and strategic advancement of the University of Guam;

WHEREAS, Mr. Wiegand began his tenure with the University in 2015, following a long and accomplished career that included roles as Audit Supervisor for Deloitte and Touche, Underwriting Manager for PacifiCare Asia Pacific, Audit Manager at the Guam Office of the Public Auditor, and Chief Financial Officer for the Guam Power Authority:

WHEREAS, he holds professional credentials as a Certified Public Accountant (CPA), Certified Government Financial Manager (CGFM), and Certified Fraud Examiner (CFE), and earned his Bachelor of Arts in Business Finance from Seattle Pacific University and a Master of Business Administration from the University of Washington;

WHEREAS, throughout his tenure, Mr. Wiegand demonstrated exceptional leadership during times of uncertainty, playing a critical role in guiding the University through the COVID-19 pandemic and Typhoon Mawar, ensuring continuity of operations and stability across departments;

WHEREAS, he was instrumental in implementing key institutional policies, including the updated travel policy and the Professional and Technical Employee Manual, as well as serving as the administrative liaison to the Staff Council, reinforcing the institution's commitment to shared governance and staff advocacy;

WHEREAS, Mr. Wiegand led major infrastructure initiatives including the successful completion of the Siemens project, which retrofitted the campus with modern, energy-efficient lighting and air conditioning systems, significantly improving campus sustainability and cost savings;

WHEREAS, he helped establish the University's Risk Management Office at the direction of the Board of Regents, ensuring a proactive and strategic approach to institutional risk and compliance;

WHEREAS, Mr. Wiegand played a central role in strengthening the University's financial position, developing and enforcing disciplined financial plans, maximizing investments, and safeguarding resources to support academic priorities and long-term institutional resilience;

WHEREAS, under his leadership, the University modernized its facilities through targeted workforce training that led to the certification of facilities staff as journeymen, further advancing operational capacity and institutional self-reliance;

WHEREAS, his oversight was key to the completion of four major building projects that have transformed the University's physical and academic landscape; the Student Success Center, the School of Engineering, the School of Health, and the Water and Environmental Research Institute; creating a lasting legacy of student-centered growth and innovation;

WHEREAS, Mr. Wiegand also served on the Board of the Asia Pacific Association for Fiduciary Studies (APAFS), further extending his impact across the region through financial leadership and fiduciary governance; and

WHEREAS, the Academic, Personnel, and Tenure Committee has reviewed this resolution and recommends approval of this resolution expressing appreciation to Randall V. Wiegand for his service with UOG and the Government of Guam for 28 years to the Board of Regents (BOR).

NOW, THEREFORE, BE IT RESOLVED, that the administration, faculty, staff, and students, convey to Mr. Wiegand their sincerest gratitude for his dedication to UOG and the people of Guam, for his service as a valued member of the University community, and his devotion to the growth and prosperity of our island and region; and

BE IT FURTHER RESOLVED, that copies of his resolution will be sent to Mr. Randall V. Wiegand, the Governor of Guam, and the Speaker and members of the Guam Legislature.
