1. Participant Agreement & Liability Waiver

In consideration of being permitted to participate in the **UOG Charter Day Battle of the Bands**, all members of the participating band hereby acknowledge and agree to the following:

- **Assumption of Risk:** Participants acknowledge that musical performance and event participation involve inherent risks, including but not limited to equipment transport, stage movement, and high-volume sound exposure.
- **Release of Liability:** I hereby release the University of Guam, its Board of Regents, officers, employees, and volunteers from all claims, damages, or injuries arising from my participation in this event, except in cases of gross negligence by the University.
- **Personal Property:** I understand that the "Plug & Play" policy requires me to bring my own instruments. The University of Guam is not responsible for the loss, theft, or damage of personal musical instruments, pedals, or equipment brought onto campus.

2. Media and Publicity Release

I hereby grant the University of Guam (UOG) Marketing Team, its representatives, and authorized news/media outlets the absolute right and permission to:

- Record my performance via video, audio, and photography.
- Use my name, likeness, and band's image in promotional materials, social media, university publications, and news broadcasts.
- Distribute this content for educational, archival, or promotional purposes related to the University in perpetuity.

- **Family-Friendly Content:** All lyrics, stage banter, and attire must be appropriate for a diverse, family-friendly audience. Profanity or suggestive behavior may result in immediate disqualification and sound cut-off.
- **Campus Policy:** Participants must adhere to all UOG campus policies, including the prohibition of alcohol, controlled substances, and tobacco on event grounds.
- **Technical Compliance:** Bands must adhere to the "Plug & Play" policy. Modification of university-provided PA systems or speakers is strictly prohibited.
