<u>Background</u>: Under the original twice-monthly meeting schedule, the traditional cycle of distribution, presentation and action was usually completed in four to five weeks, at the second meeting following the one at which an item was distributed. Since the Senate adopted a monthly meeting schedule, however, the three-step cycle now requires eight to nine weeks. The following amendment would restore the normal transaction time from distribution to action to four to five weeks and preserve the same opportunity for critical review, consultation, and discourse on each item of business coming to the Senate. It also encourages applications of advances in communication technology that facilitate distribution, review and interaction.

Review Process: This request was reviewed by the SEC on August 22, 2014 and was presented on October 16, 2014.
