 - Request for New Graduate Degree Program: Master of Science in Sustainable Agriculture, Food, and Natural Resources. Log no. 5277. Contact person M. Marutani (marutani@uguam.uog.edu). Redistributed to GCRC on 26 January 2016.

<u>Background</u>: The intention of this request is to create a new MS in Sustainable Agriculture, Food, and Natural Resources. This new program is designed to meet some of UOG's responsibilities as a land-grant institution to train graduates to meet the interdisciplinary challenges facing agriculture in the 21st century in environmental, social, agronomic, and philosophical issues.

Review Process: This request has received the following endorsements: Division Chair on 5 April 2013, from the College AAC Chair on 13 April 2013, and from the College Dean on 29 November 2015. The GCRC Chair presented the committee's recommendation to the Faculty Senate on 10 November 2016.

MOTION: To endorse the GCRC's recommendation on the request for a new graduate degree program in Master of Science in Sustainable Agriculture, Food, and Natural Resources as contained in attachment 1.

2. <u>Graduate Program Change: Master of Science in Biology</u>. Log no. 5381. Contact person D. Lindstrom (dlindstrom@triton.uog.edu). *Distributed to GCRC on 22 April 2016*.

<u>Background</u>: The intention of this request is to change the core requirements of the MS in Biology by removing BI 505 (Advances in Tropical Ecology—3 credit hours) and adding BI/EV 551 (Population Ecology—3 credit hours) plus BI/EV 551L (Population Ecology Lab—1 credit hour) because a suitable instructor for BI 505 is unavailable and BI/EV 551/L are course which parallel the technological breakthroughs of the discipline.

<u>Review Process</u>: This request has received the following endorsements: Program, Division, and College AAC Chairs on 8 April 2016, and from the College Dean on 20 April 2016. The GCRC Chair presented the committee's recommendation to the Faculty Senate on 10 November 2016.

<u>Background</u>: The intention of this request is to merge the current Tropical Agriculture Science Program with the current Consumer Family Sciences Program in accordance with UOG's Good to Great initiative. This merger would result in the new undergraduate program BS in Agriculture and Life Science (ALS).

Review Process: This request has received the following endorsements: Acting Program Chair on 1 April 2016, AAC Chair on 15 April 2016, and the College Dean on 28 April 2016. The UCRC Chair presented the committee's recommendation to the Faculty Senate on 10 November 2016.

4 <u>Proposal to change the UOG Undergraduate Catalog with respect to Retaking of Courses Multiple Times.</u> Log no. 5437 & 5437a. Contact person M. Gunn (gunnm@triton.uog.edu). *Distributed to UCRC and SCE on 8 September 2016.*

<u>Background</u>: The intention of this request is to change the catalog with respect to the retaking of courses, for which students have earned a grade of D, F, and/or W. If students wish to attempt the course for a third time, they must obtain formal counseling from their academic advisor and course approval from the appropriate school or college Dean. Fourth or subsequent attempts to complete the course will not be allowed, barring documenting extenuating circumstances.

Review Process: This request was reviewed by both the SCE and the UCRC. The SCE Chair presented these committees' recommendation to the Faculty Senate on 10 November 2016.

MOTION: To endorse the UCRC's and SCE's recommendation on the proposal to change the undergraduate catalog with respect to retaking courses and retaking courses multiple times as contained in attachment 4.

Any student desiring to retake a D, F, W, or UW course for a third time must receive formal counseling from their academic advisor and a signed "Repeat Clearance Form" from the appropriate school or college Dean.

<u>Background</u>: The intention of this request is to eliminate the transition courses in English and revise the first-year experience. This requires the removal of EN 085/L (Fundamentals of English/Lab) and EN 100 (Fundamentals of College English) and the addition of the new course EN 109—Introduction to College Composition (4 credit hours). This will also require a revision to the Academic Policies and Regulations with respect to English Composition Course Placement and Transition Student Advisement Policies.

Review Process: This request has received the following endorsements: Program and Division Chairs on 20 September 2016, College AAC Chair on 23 September 2016, and the College Dean on 26 September 2016. The UCRC Chair presented the committee's recommendation to the Faculty Senate on 10 November 2016.

Its technical review was completed on 21 October 2016. The UCRC Chair presented the committee's recommendation to the Faculty Senate on 10 November 2016.
