Background: The purpose of this request is to change the degree/graduation requirements, such that students who lack no more that 6 credit hours (including "incompletes") may participate in Spring Commencement exercises and then complete those courses during the summer immediately following the Spring Commencement. This request also includes additional caveats: this will require the Dean's approval, this will be the only commencement ceremony in which the student may participate, the actual diploma will be held until all degree requirements have been met, the student must already be enrolled and have paid for the required summer classes, the student must not have any outstanding debts to the university, and a notation in the program will indicate that they will be a summer graduate.
