Background: This request is for a new undergraduate laboratory course CH 350L: Foundations of Physical Chemistry Laboratory which is the laboratory portion of CH 350. The course covers the experimental exercises for the lecture topics and includes thermodynamics, kinetics, spectroscopy, equilibrium, acid-base equilibrium and electrochemistry. This course will be required for 3 of the 4 tracks in Chemistry (BS in Chemistry Pre-Pharmacy track, BA in Chemistry for Teaching track, and BS in Chemistry–BS in Biology Dual Degree track).

Background: This request is to expand the program to include 4 tracks: BS in Chemistry track (68 credit hours), BS in Chemistry Pre-Pharmacy track (86–87 credit hours), BA in Chemistry for Teaching track (86–87 credit hours), and BS in Chemistry–BS in Biology Dual Degree track (94–95 credit hours). These tracks take advantage of the new GE framework and are intended to increase enrollment in Chemistry in response to the G2G requirement of at least 5 graduates per year.

2. Request for Graduate New Course: GE 580 Special Topics in Geography. Log no. 5582. Reviewed by GCRC (L. Kabigting, Chair). A. Owen (aowen@triton.uog.edu) *Distributed to GCRC on 28 February 2017.*

Background: This request is for a new course that focuses on special topics in cultural or physical geography at the graduate level. Students will conduct research on a region within the Asia–Pacific within an historical context (if possible). This course includes the possibility of focusing on topics such as remote sensing, natural resources, environment, climate change, GIS, culture, globalization, politics, economy, technology,



sustainability, and health. The course may be repeated for credit, if the topics differ. The course bridges a gap for graduate students in Sustainable Agriculture, Food, and Natural Resources, as well as Micronesian Studies. The course will be taught simultaneously with GE 480, so no additional resources are required.




