Intellectual Property: Patents, Inventions, and Copyright Policy. Log No. 5798. Reviewed by SCIE (K. Smith, Chair). Contact person D. McKay (dmckay@triton.uog.edu). Distributed to SCIE on 13 November 2017.

<u>Background</u>: This request is to update, expand, and improve UOG's Intellectual Property Policy. The new policy increases the potential share of the "creator" from 33% to 40–45% of the royalty income and provides more comprehensive guidance on handling intellectual property issues, including the composition of the Innovation Policy Board.

Review Process: This request was created by an ad hoc committee of faculty and administrators (13 February 2018). It was reviewed by the Research Council (12 February 2018) and the Administrative

Council (12 February 2018). The RFK Academic Affairs Committee reviewed the Copyright section (13 February 2018).

<u>Background</u>: This request is to change the current Communications Program from 2 tracks to 4 tracks (Communication Studies, Public Relations, Journalism, and Digital Cinema & Media). In conjunction with this change, the credit hours required for the program would be increased from 45 credit hours to 51 credit hours and the courses required for each track are defined.

<u>Background</u>: This request is to add to the allowable situations in which a student may retake a class to include classes for which a student has received a grade between C and B+. Students who wish to retake a course under these circumstances must receive approval of the program and the Dean of the college that offers the course. Note however, that students who are taking the course for the first time will be given priority. If a course is repeated, the course (and original grade) will appear on the student's transcripts, but only the last grade achieved for the course will be included in the student's GPA.

<u>Background</u>: This request is to allow students to repeat courses for which they have earned a C- or less. The current policy only allows students who have earned a D, F, or W to repeat a course. However, with the change in the UOG grading system to include +/- grades, a C- is below (GPA 1.70) the GPA necessary to remain in good academic standing (GPA 2.00).

<u>Background</u>: This request is to remove PS 100—Introduction to Citizenship from the curriculum. This course was intended for non-majors, who required a GE course in "The Individual & Society," and who were restricted to developmental English. This course is no longer a GE course and developmental English is no longer offered, so there is no longer a need for this class.

The course is designed for senior undergraduates who have successfully completed PS 225—State and Territorial Government. This course examines the political relationship among indigenous and non-indigenous peoples and colonial powers, as well as national and international communities. This course is considered particularly timely as Guam examines its own political structure and relationships. This course will be taught by existing faculty.

<u>Background</u>: This request is to add the course MA 089 (Fundamentals of Mathematics) to the courses offered at UOG. This course is considered a "special needs" course because it is comprised of the fundamental concepts of high-school mathematics and is not for college credit. The course consists of 5 lecture hours each week (5 cr.) and covers the same material as the 2 semesters of MA 085a and MA085b. This new course allows students in developmental mathematics to progress more quickly (1 semester, rather than 2) to college-level classes in mathematics.
