#### **MINIMUM QUALIFICATION:**

High School Diploma or GED, and 31-90 college credits OR 3 years of relevant and related work experience.

#### **NECESSARY SPECIAL QUALIFICATION:**

Must have a valid driver's license.

#### **QUALIFICATIONS REQUIRED:**

Pursuant to Public Law 26-87 as amended by Public Law 29-113, all future employees of any position within the government of Guam will be required at minimum to possess one of the following:

- 1. A high school diploma; or
- 2. Successful completion of General Education Development (GED) Test; or
- 3. The equivalent of a general education high school program; or
- 4. Successful completion of a certification program, from a recognized accredited or certified vocational technical institution, in a specialized field for the job.

## **CHARACTER OF DUTIES:**

Under the supervision of Agricultural Economist and Extensionist, the Extension Assistant II will assist in continuing phases of the baseline survey distribution, collection, and analysis for the farmer worker stress surveys under the Western Region Agricultural Stress Assistance Program (WRASAP). The employee will work closely with co-investigators and collaborators to assist and implement proper research procedures. This will include conducting literature searches, coordinating study activities, and evaluating all methodology that is respective of scientific and applied aspects. The ability to work effectively in an inter-disciplinary team is needed to create liaison relationships for existing collaborations between the Commonwealth of the Northern Mariana Islands, Federated States of Micronesia, as well as potential partners at local and regional levels. The employee should ensure success for outreach activities on mental health awareness techniques, trainings, and conferences.

#### **KNOWLEDGE, ABILITIES AND/OR SKILLS:**

Providing information in written form, e-mail, or in-person. To undertake literature reviews and contribute to the production of research reports, conference papers, and peer-reviewed journals where appropriate. Experience with data entry, data management and demonstrated ability to learn and use new software systems. Demonstrate experience working collaboratively as a member of a multidisciplinary team. Responsible for providing administrative project support to assure high-quality management for research projects and relations.

#### **EDUCATION:**

Applicants claiming degrees or credit hours are required to have an original or certified copy of the documents (e.g. transcripts, high school diploma or GED certification) accompany the application.

#### WORK ELIGIBILITY:

Submission of completed job applications authorizes the University of Guam to seek and obtain information regarding the applicant's suitability for employment. All factors which are job related may be investigated (e.g. previous employment, educational credentials, and criminal records). All information obtained may be used to determine the applicant's eligibility for employment in accordance with equal employment opportunity guidelines. In addition, the applicant releases previous employers and job related sources from legal liability for the information provided.

Section 25103, Chapter 25, Title 10 of the Guam Code Annotated requires college or university employees to undergo a physical examination, to include a test for tuberculosis (skin or x-ray), prior to employment and at least annually thereafter.

A report of such examination must be conducted by a licensed physician within a state or territory of the United States and must be submitted upon request.

Federal law requires presentation of eligibility to work in the United States within seventy-two (72) hours of reporting for employment. Specifically, 8 USC 1324A requires the employer to verify the identity and eligibility to work in the United States of all newly hired employees. The University of Guam is required to comply with this law on a non-discriminatory basis. If you are hired to fill a position within the University of Guam, you will be required to present valid documents to comply with the law.

#### **POLICE AND COURT CLEARANCE:**

Pursuant to Public Law No. 28-24 and Executive Order No. 2005-34, applicants selected for a position are required to provide original police and court (Superior Court of Guam) clearances of no more than three (3) months old prior to commencement of employment. Off-island applicants must obtain clearances from their place of residence. Applicants are responsible for fees associated with obtaining the clearances.
