# **MINIMUM QUALIFICATIONS:**

• Bachelor's degree, and experience with COVID-19 preparation and response.

# **NECESSARY SPECIAL QUALIFICATIONS:**

• Possession of a valid driver's license.

# **QUALIFICATIONS REQUIRED:**

Pursuant to Public Law 26-87 as amended by Public Law 29-113, all future employees of any position within the Government of Guam will be required at minimum to possess one of the following:

- 1. A high school diploma; or
- 2. Successful completion of General Education Development (GED) Test; or
- 3. The equivalent of a general education high school program; or
- 4. Successful completion of a certification program, from a recognized accredited or certified vocational technical institution, in a specialized field for the job.

# KNOWLEDGE, ABILITIES AND/OR SKILLS:

Knowledge of basic Microsoft Office applications. Highly organized; knowledge of other software packages, including design software. Have some knowledge of the University of Guam procurement process. Abilities to write, perform computer design work, perform research, think critically, perform basic construction work and lift 35 pounds. Ability to work within deadlines—many short; proactive. Experience with COVID-19 preparation and response. Customer service focused, and provide exemplary customer service, as appropriate.

# **CHARACTER OF DUTIES:**

- Help coordinate Strategic Plan: tracking, implementation, writing.
- University Policy Manual: research and writing, website content filling and design, assist sub-unit manuals.
- Board of Regents: research, organization of materials, putting files in share drive.
- Co-coordinate COVID-19 preparation and response support, including training and coaching.
- Coordinate Facilities Management & Services: measuring rooms, recon of services and pricing, training on new Facilities Management & Services (FMS) software.
- President: other duties as assigned by the President of UOG.

# **EDUCATION:**

Applicants claiming degrees or credit hours are required to upload a certified copy of the documents (e.g., transcripts, high school diploma, or GED certification) with the online job application through UOG's online employment portal at <a href="http://uog.peopleadmin.com">http://uog.peopleadmin.com</a>.

#### **WORK ELIGIBILITY:**

Submission of completed job applications authorizes the University of Guam to seek and obtain information regarding the applicant's suitability for employment. All factors which are job-related may be investigated (e.g., previous employment, educational credentials, and criminal records). All information obtained may be used to determine the applicant's eligibility for employment in accordance with equal employment opportunity guidelines. In addition, the applicant releases previous employers and job-related sources from legal liability for the information provided.

# #061-21 PROJECT COORDINATOR

Section 25103, Chapter 25, Title 10 of the Guam Code Annotated requires college or university employees to undergo a physical examination, to include a test for tuberculosis (skin or x-ray), prior to employment and at least annually thereafter. A report of such examination must be conducted by a licensed physician within a state or territory of the United States and must be submitted upon request.

Federal law requires presentation of eligibility to work in the United States within seventy-two (72) hours of reporting for employment. Specifically, 8 USC 1324A requires the employer to verify the identity and eligibility to work in the United States of all newly hired employees. The University of Guam is required to comply with this law on a non-discriminatory basis. If you are hired to fill a position within the University of Guam, you will be required to present valid documents to comply with the law.

#### POLICE AND COURT CLEARANCE:

Pursuant to Public Law No. 28-24 and Executive Order No. 2005-34, applicants selected for a position are required to provide original police and court (Superior Court of Guam) clearances of no more than three (3) months old prior to commencement of employment. Off-island applicants must obtain clearances from their place of residence. Applicants are responsible for fees associated with obtaining the clearances.
