University Information:

The University of Guam is the premier institution of higher education in the Western Pacific. It is a land-grant, a seagrant, and a space-grant institution, accredited by the Western Association of Schools and Colleges Senior Commission. Located in the village of Mangilao on the island of Guam, the campus overlooks the beautiful Pago Bay and the University's world-class Marine Laboratory and Water and Energy Research Institute of the Western Pacific. The University has 3,400 students, 47% of Asian ethnicity and 45% of Pacific Islander ancestry, providing a uniquely diverse campus and multicultural atmosphere. As a regional, comprehensive, open-admissions institution, the University awards degrees at the certificate, baccalaureate, and master's levels through its two colleges and four professional schools. The institution's mission of Ina (to Enlighten), Diskubre (to Discover), Setbe (to Service) serve as the foundation for the institution's Para Hulo' strategic plan, with its vision to transform lives and advance communities as a land-grant, a seagrant, and a space-grant university. One of the university's key strategic initiatives is to be recognized as a research university centered in Island Wisdom. Island Wisdom acknowledges that Pacific ways of knowing and Western models of higher education are central to the institution's teaching, research, and service endeavors, and that balanced consideration of the ideas that emerge from them is essential to the prosperity and sustainability of island communities. Through its robust research portfolio fueled by extramural funding from competitive grants and contracts, the University delivers public value through dedicated and capable administration, faculty, students, and staff. As a complement to the research carried out at the institution, the University of Guam has an active press dedicated to publishing research and writing about Guam and Micronesia. A variety of publishing opportunities are available to UOG faculty, employees, students, and members of the communities we serve through the University of Guam Press. UOG is a safe and secure campus, where the institution places paramount importance on the physical, intellectual, emotion, and spiritual wellbeing of its students and employees. It fosters open dialogue and collegiality based upon mutual respect for diverse perspectives. General Description:

The University of Guam is looking for an individual who is interested in new challenges and opportunities for professional and personal growth. This position calls for someone who is self-motivated and adaptable, intelligent, possesses a global vision and who is interested in working in a dynamic, multi-cultural institution.

Unit Description:

The Dean of the College of Natural and Applied Sciences (CNAS) serves as Director of the Cooperative Extension Service (CES) and the Western Pacific Tropical Research Center (WPTRC). Within CES there are two (2) program areas: (1) Agriculture and Natural Resources (ANR) and (2) Communities, Youth, Families, Food and Nutrition (CYFFN). The ANR program houses six (6) tenure track and one (1) non-tenure track faculty members: two (2) Horticulture faculty (the advertised position), one (1) Entomology faculty, one (1) Agriculture Economics faculty, one (1) Animal Science faculty, one (1) Plant Pathology faculty, and one (1) non-tenure track sustainable agriculture/community wellness faculty. The ANR program also has Extension associates and assistants under its umbrella. The CYFFN program houses five (5) faculty as well as several Extension associates and assistants. University of Guam Cooperative Extension Services (UOG/CES) enables the multicultural community of Guam to make informed decisions through non-formal education programs based on research and identified local needs.

Character of Duties:

This position is a 12-month tenure track Extension faculty position in horticulture under the ANR Program to focus on direct field work with producers on tropical vegetable and fruit production, arboriculture, soil and water conservation, and some invasive species issues. The successful applicant will have as his/her primary role "Extension and Community Outreach" and will be expected to plan, organize, implement, and evaluate non-formal Extension education programs in tropical horticulture for Guam and the Western Pacific. These programs are driven by needs assessments conducted under 5-year federally approved Plans of Work (POW). As a tenure track Extension faculty, the successful applicant must also be willing to support the teaching and research efforts of CNAS. As a tenure track faculty, the successful applicant must meet the tenure requirements to develop a portfolio of accomplishments that reflect a minimum of 50% within the primary endeavor (Extension and Community Outreach), 25% secondary endeavor (Creative, Scholarly & Research), and 15% Service during the first five (5) years of the tenure track appointment.

The Extension faculty works as a member of the UOG/CES team and as a representative of the University of Guam. The successful candidate will work under the ANR Extension Unit and provide leadership support for Horticulture issues and programs supporting commercial and subsistence producers/groups, and work across the various Extension Plan of Work areas.

The successful candidate is expected to:

- Develop effective, science-based tools for local fruit, vegetable, and ornamental crop production to enhance the productivity and sustainability of locally-grown crops while promoting soil and water conservation practices.
- Teach a minimum of one (1) college level course, or courses equivalent to three (3) contact hours, in his/her area of discipline per academic year and participate in University and College committees as well as community service and research endeavors.

- Conduct training and create research-based information for clientele (leaflets, flyers, bulletins, etc.), on small farm food and ornamental crop production, including small-scale mixed crop production, organic farming, agroforestry, arboriculture, soil and water conservation, and subsistence farming with a tropical island focus.
- Assess community needs, plan, implement, and evaluate an effective outcome-based program that supports identified issues in the local farming and gardening communities. Effectively report, market, and interpret results of programming efforts.
- Develop and maintain positive relationships among diverse groups and stakeholders to assess community needs and concerns, to leverage efforts with local agencies and producer groups.
- Evaluate and address programmatic need for arboriculture, and other forms of plant management.
- Develop a horticultural research program with a record of successful extramural crops to include conducting a minimum of one (1) set of variety trials each year, primarily on food crops.
- Collaborate with other Extension faculty and staff and various local and federal agencies (e.g., United States Department of Agriculture - Natural Resources Conservation Service (USDA-NRCS), Government of Guam Department of Agriculture, etc.) to plan, execute, and evaluate programs related to local and regional agricultural and natural resource initiatives.
- Develop and carry out the plans of work approved by USDA.
- Regional participation with other U.S. insular areas of the Pacific as well as freely associated states in Micronesia is encouraged.

Qualifications:

Minimum: 1) Earned Master's Degree in horticulture; or closely related plant production/protection field from a U.S. regionally accredited institution or foreign equivalent; 2) Demonstrated knowledge and experience with tropical vegetable and fruit production, and knowledge of federal programs supporting production and soil and water conservation; 3) At least five (5) or more years of experience working in Cooperative Extension of other non-formal instruction and/or related outreach programs; demonstrated ability to secure and manage competitive grants; 4) Knowledge and experience with arboriculture trainings; 5) Demonstrated ability to communicate, interact, and collaborate effectively with students, colleagues, and the community, both orally and in writing; 6) Ability and willingness to work with people of diverse cultures, backgrounds, and economic status; 7) knowledge and experience and 8) Experience with nursery and plant propagation techniques and a familiarity with pest management strategies. Must be willing to teach online.

Preferred: 1) Ph.D. in horticultural science with an emphasis in vegetable and fruit production; or other related field, from a regionally-accredited U.S. institution or foreign equivalent; 2) Experience working in and knowledge of the land grant system and Cooperative Extension program delivery, and in promoting federal farmer assistance programs; 4) Arborist certifications; 3) Demonstrated ability to secure and manage competitive grants; 4) Five (5) years of work experience with issues related to horticulture production, sustainable production methods with a preference for work with tropical agriculture, and/or natural resources; 5) Knowledge of or experience in working with multicultural populations; 6) Experience in crop production, plant protection and invasive species outreach education; 7) Nursery and plant propagation expertise (including backyard level), experience implementing pest management strategies, knowledge of organic production methods, and experience with soil and water conservation programs/practices.

Salary Level:

Salary will be commensurate with qualifications and experience relevant to the position. The following salary figures are for twelve (12) months:

Compensation for employment shall not commence until all hiring conditions are met, including required employment visa. Annual salary will be prorated, if start of employment is delayed.

Appointment/ Relocation:

The position is a twelve (12) month faculty position, three-year tenure track or non-tenure track contractual appointment. The University provides relocation assistance to new employees if hired off-island on a three-year initial contract. Provided are travel expenses for the applicant and the applicant's spouse (as defined by Guam Law) and children under the age of 18 by the least expensive and most direct air route from the point of hire and for moving household goods to Guam by the least expensive carrier up to 3,500 pounds for a family and 1,750 pounds for an applicant without dependents. Insurance of household goods, if desired, is at the employee's expense.

Benefits:

Fringe benefits include a medical and dental plan, life insurance, cafeteria plan (flexible tax benefit plan), annual leave, sick leave, and the Government of Guam retirement plan.

position are required to provide original police and court (Superior Court of Guam) clearances of no more than three (3) months old prior to commencement of employment. Off-island applicants must obtain clearances from their place of residence. Applicants are responsible for fees associated with obtaining the clearances.

Work Eligibility:

Submission of completed job applications authorizes the University of Guam to seek and obtain information regarding the applicant's suitability for employment. All factors which are job related may be investigated (i.e., previous employment, educational credentials, and criminal records). All information obtained may be used to determine the applicant's eligibility for employment in accordance with equal employment opportunity guidelines. In addition, the applicant releases previous employers and job-related sources from legal liability for the information provided.

Should an applicant be convicted of any crimes other than a minor traffic violation, all applicable information must be provided in the form of a police clearance report and court clearance report. Failure to admit any felony convictions may result in immediate disqualification or disciplinary action.

Section 25103, Chapter 25, Title 10 of the Guam Code Annotated requires college or university employees to undergo a physical examination, to include a test for tuberculosis (skin or x-ray), prior to employment and at least annually thereafter. A report of such examination must be conducted by a licensed physician within a state or territory of the United States and must be submitted upon request.

Federal law requires presentation of eligibility to work in the United States within seventy-two (72) hours of reporting for employment. Specifically, 8 USC 1324A requires the employer to verify the identity and eligibility to work in the United States of all newly hired employees. The University of Guam is required to comply with this law on a non-discriminatory basis. If you are hired to fill a position with the University of Guam, you will be required to present valid documents to comply with this law.
