MINIMUM QUALIFICATION:

High School Diploma or GED and 90 or more college credits or five (5) years relevant and related work experience

PREFERRED QUALIFICATION:

Knowledge in Pesticide Application Education. Currently enrolled at UOG and declared major of the ALS Undergraduate Degree Program

KNOWLEDGE, ABILITIES, AND/OR SKILLS:

Must have the ability to manage multiple tasks under tight deadlines. Must be skillful in the use of computer peripheral/accessories to create or record educational materials. Must have strong verbal and written communication skills. Must be knowledgeable of Microsoft applications or iOS equivalents to work effectively with the public and other employees.

CHARACTER OF DUTIES:

Under the supervision of the Agriculture Extension Agent, the Extension Assistant III will assist to create a draft of the Guam Fruit and Vegetable Pesticide Guide, develop online training sources for the Pesticide Safety Education Program (PSEP) and develop a swimming pool pest management training manual for pesticide applicators.

EDUCATION:

Applicants claiming degrees or credit hours are required to have an original or certified copy of the documents (e.g. transcripts, high school diploma or GED certification) accompany the application.

WORK ELIGIBILITY:

Submission of completed job applications authorizes the University of Guam to seek and obtain information regarding the applicant's suitability for employment. All factors which are job related may be investigated (e.g. previous employment, educational credentials, and criminal records). All information obtained may be used to determine the applicant's eligibility for employment in accordance with equal employment opportunity guidelines. In addition, the applicant releases previous employers and job related sources from legal liability for the information provided.

Section 25103, Chapter 25, Title 10 of the Guam Code Annotated requires college or university employees to undergo a physical examination, to include a test for tuberculosis (skin or x-ray), prior to employment and at least annually thereafter. A report of such examination must be conducted by a licensed physician within a state or territory of the United States and must be submitted upon request.

Federal law requires presentation of eligibility to work in the United States within seventy-two (72) hours of reporting for employment. Specifically, 8 USC 1324A requires the employer to verify the identity and eligibility to work in the United States of all newly hired employees. The University of Guam is required to comply with this law on a non-discriminatory basis. If you are hired to fill a position within the University of Guam, you will be required to present valid documents to comply with the law.

POLICE AND COURT CLEARANCE:

Pursuant to Public Law No. 28-24 and Executive Order No. 2005-34, applicants selected for a position are required to provide original police and court (Superior Court of Guam) clearances of no more than three (3) months old prior to commencement of employment. Off-island applicants must obtain clearances from their place of residence. Applicants are responsible for fees associated with obtaining the clearances.
