**MINIMUM EXPERIENCE AND TRAINING:**

- Four (4) years of experience in the installation, maintenance, and repair of refrigeration equipment; or
- Any equivalent combination of experience and training which provides the minimum knowledge, abilities, and skills.

**QUALIFICATIONS REQUIRED:**

Pursuant to Public Law 26-87 as amended by Public Law 29-113, all future employees of any position within the government of Guam will be required at minimum to possess one of the following:

1. A high school diploma; or
2. Successful completion of General Education Development (GED) Test; or
3. The equivalent of a general education high school program; or
4. Successful completion of a certification program, from a recognized accredited or certified vocational technical institution, in a specialized field for the job.

**NATURE OF WORK IN THIS CLASS:**

Performs skilled refrigeration work in the installation, maintenance and repair of refrigeration equipment. Employees in this class perform the full range of skilled tasks under general supervision and may lead less skilled workers on assigned tasks.

**MINIMUM KNOWLEDGE, ABILITIES, AND SKILLS:**

Knowledge of the principles, methods, practices, tools and equipment used in the installation, maintenance and repair of refrigeration equipment. Ability to read, interpret and work directly from wiring diagrams, specifications, and manuals. Ability to take and record readings from thermometers, gauges. Ability to perform arduous physical tasks including heavy lifting and working in strained and awkward positions. Ability to understand and follow written and oral instructions. Ability to apply safe work practices. Skill in the refrigeration mechanic trade.

**ILLUSTRATIVE EXAMPLES OF WORK:**

(These examples do not list all the duties which may be assigned; any one position may not include all the duties listed.)  
Installs, maintains and repairs refrigerator, air conditioners, water cooling systems according to blueprints and engineering specifications. Determines proper placement of structural and functional components. Drill holes and installs mounting brackets and hangers into floor and walls of building; lifts and aligns components. Assembles structural and functional components such as motors, controls, switches; gauges, wiring harnesses, valves, pumps, compressors, condensers, cores, and pipes by screwing, bolting, riveting, welding and brazing; cuts, threads, and connects pipes to functional components and water or power system; pumps specified fluid into system. Starts system; observes operation; reads gauges and instruments; and adjusts mechanisms such as valves, controls and pumps to control level of fluid pressure and temperature in system; dismantles malfunctioning systems and test components; replaces and adjusts defective or worn out parts to repair systems. May insulate cabinets of systems. May install wiring to connect components to electric power source. Performs related duties as required.

**EDUCATION:**

Applicants claiming degrees or credit hours are required to upload a certified copy of the documents (e.g., unofficial transcripts, high school diploma, or GED certification) with an online job application through the UOG's online employment portal at <https://uog.peopleadmin.com>. Upon selection, the selected candidate will be required to submit an official transcripts to the University of Guam Human Resources Office.

**VETERANS / DISABILITY PREFERENCE:**

Applicants claiming veteran's preference points are required to provide a copy of the DD-214 (Military Discharge form). Those claiming Compensable Disability are required to provide a copy of a letter from the Veterans Administration. Applicants claiming disability preference should submit a Government of Guam Certification, Certified by the Director of Public Health and Social Services.

### **PREFERENTIAL HIRING STATUS:**

As a recipient of an educational loan or merit scholarship, you are entitled to first offer of employment in accordance with Public Law 15-127 (notwithstanding any other laws which may supersede). To claim preferential hire, you must upload your eligibility letter from the University of Guam Financial Aid Office, along with your job application. Preference hiring is only awarded for initial employment. In addition, declining an offer will result in the removal of preferential hire status.

### **WORK ELIGIBILITY:**

Submission of completed job applications authorizes the University of Guam to seek and obtain information regarding the applicant's suitability for employment. All factors which are job related may be investigated (i.e., previous employment, educational credentials, and criminal records). All information obtained may be used to determine the applicant's eligibility for employment in accordance with equal employment opportunity guidelines. In addition, the applicant releases previous employers and job related sources from legal liability for the information provided.

Section 25103, Chapter 25, Title 10 of the Guam Code Annotated requires college or university employees to undergo a physical examination, to include a test for tuberculosis (skin or x-ray), prior to employment and at least annually thereafter. A report of such examination must be conducted by a licensed physician within a state or territory of the United States and must be submitted upon request.

Federal law requires presentation of eligibility to work in the United States within seventy-two (72) hours of reporting for employment. Specifically, 8 USC 1324A requires the employer to verify the identity and eligibility to work in the United States of all newly hired employees. The University of Guam is required to comply with this law on a non-discriminatory basis. If you are hired to fill a position within the University of Guam, you will be required to present valid documents to comply with the law.

### **POLICE AND COURT CLEARANCE:**

Pursuant to Public Law No. 28-24 and Executive Order No. 2005-34, applicants selected for a position are required to provide original police and court (Superior Court of Guam) clearances of no more than three (3) months old prior to commencement of employment. Off-island applicants must obtain clearances from their place of residence. Applicants are responsible for fees associated with obtaining the clearances.
