The University of Guam is requesting that your total BID OFFER PRICE be made in sub-offers; representing the implementation sequence expected for the implementation of this project. This is being requested in case the University receives BID OFFERS (Basic + Option) that exceeds its allocated budget; since the University may choose to exercise its right to partially award this IFB.

The basic bid should include all cost related to the purchasing of the new 600 KW generator that is equal to or greater than these approved brands; such as Cummins-Onan, Caterpillar, or Kohler. The generator unit must include its Day-Tank; have continuous power without varying load for continuous power rating. Continuous power in accordance with ISO 8529 and ISO 3045. The delivery will be to UOG's Mangilao campus.

OPTION: INSTALLATION SERVICES

The option for *Installation Services* must include all work and cost needed for a complete installation that results in bringing the new 600 KW generator online and operational. The scope of services shall include:

- Replacement of the generator's Distribution Panel.
- Inclusive of any physical modifications necessary within the generator house that may be needed by the new generation that has a different physical configuration than the previous unit that was removed.
- Administrator the Permit Application (if necessary) for the installation of the new generator.
- Obtain Manufacturer's support to provide the Installation Certification for the new generator.
- Provide up to one (1) of warranty coverage on the workmanship for the installation services along with the Manufacturer's Warranty coverage for the same period.
- Test, demonstrate, and bring online the new 600 KW generator.
- Connect the new generator to the generator's distribution panel and Automatic Transfer Switch.
- Installation must include testing, on-line demonstration, and a hand over training to the UOG Electrical Supervisor and Electricians (not to exceed 8 hours).
- Providing all the supplies, materials, equipment, labor (unskilled, skilled, and technical), administrative cost, and any other expenses necessary to bring the new generator unit on-line; including any required testing by the manufacturer.
- Installation time should not exceed 30 days.
