For this IFB, we are looking for a vendor to install OS2 single-mode fiber optic cabling between the existing Computer Center and newly constructed School of Engineering building. The goal is to establish a high-performance, reliable, and standards-compliant backbone network infrastructure.

The conference was turned over to Vince to discuss the details of the scope of work needed in this IFB. He indicated that the awarded vendor will be running the Fiber Optic OS2 Cabling in the existing conduit pathways that run from OIT to the School of Engineering. UOG does not expect trenching to be required for this bid but will leave it up to the vendors, if they deem it necessary to include in their packet. We then conducted the site visit from starting point in OIT to all the underground pathways that will lead the School of Engineering building. Unfortunately, we could not enter the School of Engineering building final end point of the Fiber Optic cabling as the door was unable to open. The meeting was adjourned at 10:33 am at the School of Engineering building.
