Minimum Qualifications:

- Bachelor's degree in Botany, Ecology, Biology, Environmental Policy, Communication, or related field from a U.S. regionally accredited institution or foreign equivalent;;
- At least one (1) year experience working on listed species surveys, research or management preferably with native plants and invertebrates in the CNMI/Guam or other Pacific Islands <u>OR</u> combination of college credits, technical training, and or substantial professional level work experience;

Note:

The selected candidate is or can be added to the list of authorized individuals on a Section 10(a)(1)(A) recovery permit from the USFWS to collect, manage, propagate, and outplant native federally listed species (particularly plants and invertebrates). If the technician is not on a list of authorized individuals on a Section 10(a)(1)(A) recovery permit upon contract award, the technician must submit a request to USFWS be added to a list of authorized individuals on a Section 10(a)(1)(A) recovery permit within two weeks after employment.

Minimum Knowledge, Skills, and Abilities:

Endangered species survey experience:

- Ability to identify native plant species of Guam and the Northern Mariana Islands;
- Ability to hike through field and difficult terrain in all weather conditions;

Policy Development – policy communicator – outreach experience:

- Ability to organize, coordinate, and conduct steering committee and stakeholder groups meetings to develop a Habitat Conservation Plan for Guam;
- Ability to convene discussions and workshops;
- Ability to summarize feedback from steering committee members and stakeholder groups;
- Ability to produce outreach materials and maintain website content;
- Must be comfortable with Microsoft Outlook, managing calendars, and making phone calls to community members, stakeholders, and elected officials to assist in the communications activities of the Guam HCP;
- Ability to communicate effectively. Good verbal and written skills;
- Ability to manage time efficiently and ability to prioritize work;
- Ability to work flexible hours, including weekends and evenings, as needed;

Police and Court Clearance:

Pursuant to Public Law No. 28-24 and Executive Order No. 2005-34, applicants selected for a position are required to provide original police and court (Superior Court of Guam) clearances of no more than three (3) months old prior to commencement of employment. Off-island applicants must obtain clearances from their place of residence. Applicants are responsible for fees associated with obtaining the clearances

<u>Selected candidate</u> must provide official transcripts prior to hire date.

Work Eligibility:

- Submission of completed job applications authorizes the Research Corporation of the University of Guam to seek and obtain information regarding the applicant's suitability for employment. All factors which are job related may be investigated (i.e., previous employment, educational credentials, and criminal records).
- All information obtained may be used to determine the applicant's eligibility for employment in accordance with equal employment opportunity guidelines. In addition, the applicant releases previous employers and job-related sources from legal liability for the information provided.
- Should an applicant be convicted of any crimes other than a minor traffic violation, all applicable information must be provided in the form of a police clearance report and court clearance report. Failure to admit any felony convictions may result in immediate disqualification or disciplinary action.
- Section 25103, Chapter 25, Title 10 of the Guam Code Annotated requires college or university employees to undergo a physical examination, to include a test for tuberculosis (skin or x-ray), prior to employment and at least annually thereafter. A report of such examination must be conducted by a licensed physician within a state or territory of the United States and must be submitted upon request.
- Federal law requires presentation of eligibility to work in the United States within seventy-two (72) hours of reporting for employment. Specifically, 8 USC 1324A requires the employer to verify the identity and eligibility to work in the United States of all newly hired employees. The Research Corporation of the University of Guam is required to comply with this law on a non-discriminatory basis. If you are hired to fill a position with the Research Corporation of the University of Guam, you will be required to present valid documents to comply with this law.
