WHEREAS, the purpose of the RCUOG includes the promotion of assigned educational, scientific, and literary pursuits of the University of Guam's grants and contracts through aiding in the development of study, training, and research and to furnish the means and methods to do so: and

WHEREAS, the University of Guam begins its budget process in the second quarter for the fiscal year; and

WHEREAS, Public Law 32-114 requires the Research Corporation to submit an annual budget to the Board of Directors for approval; and

WHEREAS, the Fiscal Year 2025 operations budget upon approval by the Board of Directors, will be submitted to the University of Guam Board of Regents for approval; and

WHEREAS, the Fiscal Year 2025 operations budget is appended to this resolution as exhibit A.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors hereby adopts the Fiscal Year 2025 operations budget for the Research Corporation of the University of Guam.
