Course Description: This capstone course is taken by history majors in their senior year, culminating their degree program with a demonstration of their ability to apply historical knowledge, methods, and theories. The capstone may take the form of a public presentation of a research paper or other history project in a manner that reflects students' synthesis of key concepts from their course work. Prerequisite: HI 308 and HI 313 or 413.

Requirements and Expectations:

- 1. Attendance at regularly scheduled research consultation is required. These discussions will allow periodic checks during the semester. Missing scheduled meetings will result in a reduction of the overall grade.
- 2. Students generally build their capstone project on research done in previous history courses. The capstone course guides students as they improve upon their earlier work by reexamining primary sources and considering additional secondary sources and theoretical frameworks. Reading early and widely during the first month of the course is essential to a successful capstone project. In the first six weeks of the course you will consider new source material agreed upon with your instructor and consider how this material could augment your earlier work.
- 3. Students will be required to present their work with classmates at various points in the semester and to peer review their classmates' work. Students will be evaluated on their participation in this process.
- 4. Students will submit a final paper. Papers should be well written and well organized in support of a strong thesis and they should demonstrate a command of their chosen topic and appropriate theoretical perspectives. In addition, clarity, punctuation, grammar and spelling will figure in to your final grade.
- 5. Students will present their research paper at an arranged public meeting. Presentations should be 20 minutes in length and will include a question an answer period with the audience.
