Work during the past year wrapped up the DNA connections of the Lowland Lobbans ad I began the search for the Highland Loban branch, which has turned out to have become almost entirely spelled Logan and thus hard to find among the many other Logan families. I re-wrote the Executive Summary on the home page in August to bring the project status up to date. Spencer. *Pacific Asia Inquiry, Multidisciplinary Perspectives, Volume 11*, 2021 (in press). University of Guam, Mangilao, Guam.

This publication is a 9-page book review article on author Greg Dvorak's book, *Coral and Concrete*. Dvorak of Waseda University, Tokyo, Japan, opens his childhood memories and academic analysis of this highly secret, secluded, and heavily fortified American missile range on Kwajalein Atoll in the Marshall Islands. I included four of the photographs that I took on Kwajalein while conducting training there for the University of Guam in the 1990's.

- 2. Falcons, Calipers, Lotus Blossoms, and Musings About Egyptian Art in Noritake Fancy Ware. I researched, wrote, and provided photographs for this article published in the quarterly journal, *Noritake News*, of the Noritake collectors and dealers of Noritake *fancyware* and other Japanese porcelain collectibles (Vol. XXXII, #2, 2020). It explores the use of colors and pictographs of falcons, calipers, and lotus blossoms by the Noritake porcelain artists of the 1930's.
- 3. *Mah Jong* and Noritake? A Fine Combination. I researched, wrote, and provided photographs for this article soon to be published in the quarterly journal, *Noritake News*, of the Noritake collectors and dealers of Noritake *fancyware* and other Japanese porcelain collectibles (Vol. XXXIII, #1, 2021, in press). This article explores the images of Japanese Mah Jong tiles that are hand-painted on an extensive tea set made by the Noritake Company in Nagoya, Aichi Prefecture, Japan in the 1930's. Included is context information about the *Mah Jong* game, which originated in China and was adapted in the 1920's for Japanese use by a returning Japanese soldier. Detail examples of tile designs are shown to illustrate the complex scoring system.
