

PROFESSIONAL DEVELOPMENT

Engaging in any academic or scholarly activity as I advance in age has been a challenge for the past few years. However, I continue to be active and to find intellectual stimulation where I can. The source of that stimulation is primarily the Academy of Lifelong Learning (commonly called ALL), sponsored by the local community college for senior citizens. The program has a current enrollment of more than 500 active adults taking some 40 to 50 classes a semester. My wife and I typically sign up for eight to ten classes a semester. Some are one-time affairs; others last from four to six weeks. And the one I'm the moderator for lasts all semester.

I have found a particular interest in the history of World War II. The European Theater classes are presented by an engineer turned historian who, on the 70th anniversary of D Day spent several months in Normandy, learning as much as he could about the invasion. He's able to bring an almost first-hand observation to this class. One of my fellow class members flew in World War II and then finished his military flying career by flying B-52s out of Guam over Vietnam. It is a rich experience. Classes about the Pacific Theater of World War II are taught by an interested, but not as well informed, instructor whose sources are mostly books and videos. More than once I've found myself "re-directing" some of his comments about the war around Guam and the Western Pacific.

This semester I'm also taking classes on the dichotomy of ancient Chinese thought, critical thinking, reading music, internet bargain hunting and the early reformation. I'm also moderating, for the third semester, a class called Current Events. About 20 of us gather weekly for a couple of hours to talk about current issues, particularly in politics and world affairs. Because our community is quite conservative, this class offers an opportunity for more liberal-minded folks to speak their minds without fear. And we're finding that we living in challenging times.

SERVICE

Finally, I continue to be a leader in the Stephen Ministry of my church. These are one-on-one relationships between trained Stephen Ministers and people who are enduring some type of loss, whether death of a loved one, loss of a job, or other traumatic life event. I'm in my eighth year, find it immensely satisfying and an opportunity for committed service.

All in all, while these aren't typical professional pursuits for retired professors, I do find them fulfilling and instructive.
